



COLLISION OR UPSET COVERAGE

Refer to the Supplemental Declarations if information is not shown on this form.

For an additional premium, *we* provide coverage under this endorsement subject to the *terms* contained in the General Policy Provisions.

This policy is extended to cover direct loss to covered property caused by collision of the mobile home described on the Declarations with another object or by upset of the mobile home.

This coverage applies while the mobile home is at the location stated on the Declarations. It applies while the mobile home is away from the location stated on the Declarations if *you* have *our* written consent to move the mobile home.

This coverage is effective on _____ or as shown on the Declarations or change endorsement. Coverage applies for 30 days from the effective date.

EXCLUSIONS

Coverage under this endorsement does not apply:

- a. to a mobile home while used in any dishonest or unlawful activity; or
- b. to tires unless the loss results from other loss covered by this endorsement.

The additional premium charge is to be retained in full by *us*.
